14	environmental impacts; and,	
15	WHEREAS the housing affordability challenge is regional and is shared by each

17	WHEREAS regional cooperation and joint action is needed to produce additional	
18	accessible and affordable housing and distribute it across the county where affected populations	
19	live and work; and,	
20	WHEREAS Boulder County communities and residents are committed to and have made	
21	strong investments in housing affordability; and,	
22	WHEREAS Longmont is committed to working with its neighboring cities and towns in	
23	Boulder County to collectively create and dedicate the resources needed to successfully govern
